Hello fellow GMSAAI members. Here we are three months into the New Year and some of us have outstanding balances on our membership dues. Now you can conveniently pay our membership and registration fees through our website at (GMSAAI.org) using PayPal. Log onto the GMSAAI.org website and click on the registration link to the left of the screen, under the convention/reunion link. This link will take you to a page that has the PayPal (Pay Now

button). Click on the pay now button and it will take you to a secured page that has gmsaai.org donation. The page will have a field that says purpose and amount. In this field state the purpose of the donation, such as registration, dues or just registration. In the amount field enter the desired amount to be given. You may also submit any fundraising sales through this same portal. You must have a PayPal account to use the PayPal only feature. However, you may also submit monies by using the secure credit card feature located at the bottom of the donation page. You do not need to have a PayPal account to use this feature. Just click on the word (continue) at the bottom of this page under the (Don't have a PayPal account?) statement and you will be taken to a secured credit card page where you may enter the required fields for using the credit or debit card. For those of you, who want to continue to pay the traditional way, please send your certified checks or money

## **Educational seminar Report By Dr. Ricky Scott**

One of the purposes of our Alumni Association is to promote the education of adults who are blind or visually impaired. Thus, to achieve this purpose, the Association sponsors educational seminars on a regular basis. On Saturday March 15, 2014, the

Association in collaboration with the Raleigh-Wake Council of the Blind hosted such a seminar involving presentations providing information related to the Alumni Association, Voter Identification measure enacted by the General Assembly of North Carolina, advocacy organizations and the formal establishment of a support group for the blind and visually impaired. First, information regarding the Alumni Association was presented by former President Dr. Ricky Scott which related to the purposes of the Association, who could become members and a brief description of its activities. Following Dr. Scott's general comments, Mr. Alan Chase provided detailed information related to the Alumni Association's Envisioning Youth Empowerment Retreat which is a weeklong conference of blind and visually impaired youth who are transitioning to college. Mr. Chase provided information related to the activities planned for the summer and current

fundraising activities to support the program. Second, Attorney Klen, from Disability Rights North Carolina presented detailed information related to the Voter Identification Act which impacts all North Carolina citizens requiring that one of three types of identification be presented when voting effective in January 2016. She also mentioned that same day registration and voting had been eliminated and that early voting had been reduced to ten days and that polling hours had been reduced. She concluded her presentation by commenting about the rights of individuals with disabilities to cast a private ballot and that assistive technology is available for those who need it in order to cast their vote along with the availability of curbside voting. Third, Mr. Terry Lewis, President of the Durham Council of the Blind and First Vice-President of North Carolina Council of the Blind, presented information related to the mission of the American Council of the Blind and NC Council of the Blind. He

concluded his remarks by providing examples of the activities supported and sponsored by his local chapter.

Fourth, Ms. Miriam Dixon, President of the Wake Federation, presented information related to the philosophy of the National Federation of the Blind, the number of chapters in North Carolina and some specific information related to the Wake Chapter.

Fifth, Ms. Ginny Lou, President of the Visually Impaired Persons, support group remarked that this newly established organization, in terms of seeking tax exempt status, seeks to provide programming to support the blind and visually impaired through hosting seminars on issues impacting this population at each of its meetings. She welcomed all to attend and participate in their activities. In conclusion, it is the writer's opinion that this seminar providing information on a

variety of organizations impacting the blind and visually impaired of our local area and state was very informative and well received by all in attendance. It is his expectation that similar collaborative activities will continue into the future.

### **Finance Committee By Fred McEachern**

On November 1, 2013 GMSAAI purchased 166 shares of Fidelity Balanced Fund (FBLAX) for \$3,713.00. As an investing organization we opted to have our dividends or proceeds rolled over to purchase additional shares. We now have 170.476 shares at \$23.06 per share. We have a gross fund value of \$3,931.18. We have a net gain of \$218.18 since the November 1, 2013 purchase. Remember the market fluctuates, which means our stock value moves up or down depending on market trends.
